**I. AMENDED INDICTMENT**

The General Prosecutor of the United Nations Transitional Administration in East Timor, pursuant to his authority under UNTAET Regulation 1999/1, 2000/11, 2000/15, 2000/16 and 2000/30 charges:

**MURDER**

As set forth in this indictment, the General Prosecutor requests the Special Panel for Serious Crimes of the District Court of Dili to take jurisdiction of this matter expeditiously.

**II. NAME AND PARTICULARS OF THE ACCUSED**

**III. STATEMENT OF THE FACTS**

1. In 1999, the District of Aileu was divided into four sub-districts; Aileu City, Liquidoe, Remixio and Laulara.
2. On 30<sup>th</sup> August 1999 the people of East Timor voted in a referendum for independence from the Republic of Indonesia.
3. Following the vote, there were attacks directed against the civilian population in, among other areas, the sub-district of Aileu City.
4. On or about the 4<sup>th</sup> of September 1999, AHI (Aileu Hidup dengan Indonesia/Intergrasi) militia members and others went to the village of Menarboe, in the sub-district of Aileu City. They attacked the village, burning houses and displacing the civilian population.

5. On the same day, the commander of the AHI militia, Horacio De Araujo ordered members of the militia, including the accused AUGUSTO DOS SANTOS, to attack a man known as **Antonio Ribeiro**.
6. Augusto Dos Santos and three others, murdered Antonio Ribeiro by beating him with pieces of wood and guns.


Pursuant to the above, the Prosecutor charges;

**IV. CHARGES:**

**COUNT 1: MURDER**

On or about the 4<sup>th</sup> day of September 1999 in the District of Aileu, sub district of Aileu City, the defendant AUGUSTO DOS SANTOS did, with deliberate intent and premeditation, commit the murder of ANTONIO RIBEIRO, in violation of Section 8 UNTAET Regulation 2000/15 and Section 340 of the Indonesian Criminal Code, and is thereby responsible for MURDER.
